# **Snapshot**

The OptiPure® **OP175/16** utilizes Reverse Osmosis (RO) to remove >97% of the Total Dissolved Solids (TDS) from water. Then, a balance of minerals is dissolved into the RO water to provide optimized water with desirable TDS for the recommended applications. The system operates at line pressure and can produce up to 175+ gallons per day of optimal quality water. The OP175 processor can be wall-mounted or installed under the counter and includes integrated pre-filtration with particulate and chlorine reduction. System includes a built-in full system bypass valve. System also includes a 16-gallon atmospheric storage tank with a top-mounted variable-flow repressurization system and a sub-micron air breather, hose, tubing and fittings required for installation.

- Significantly reduces scale and corrosion problems related to high TDS, water hardness and chlorides.
- Ideal for all applications where TDS, hardness and chloride reduction are necessary to meet manufacturer's warranty requirements.
- Integrated mineral-addition cartridge provides TDS needed for conductivity sensors and optimal mineral content for all equipment applications.
- High capacity Pre-filters take out sediment and chlorine and protect the RO membrane.
- Digital before and after TDS meter for push-button monitoring of membrane performance and optimized water quality.
- Sample port allows quick and simple system checks and adjustments.
- Integrated system bypass valve eliminates service interruptions and down-time.
- · All consumables are easy-to-change Qwik-Twist cartridges.
- Built-in pressure gauge allows visual monitoring of operating pressure.


Any foodservice equipment where it it desireable to remove existing Total Dissolved Solids (TDS) and provide a consistent balance of buffered TDS.


# **Installation Tips**

- Feed-water connection to system should be COLD only.
- Do not exceed system specifications for temperature and pressure.
- Provide a dedicated water line of at least 1/2" I.D. to the unit for consistent flow and pressure to the system.
- Allow 3" clearance below system for filter cartridge removal and replacement.
- Connect filtered water line to steam production connections only. Do not use for condenser water.
- Detailed installation, operation and maintenance manual are included with each system.

It is recommended that pre/post-filters and mineral addition cartridges are changed every 6 months, when capacity is reached or when feedwater pressure or flow becomes inadequate.

Membrane life varies depending on feedwater conditions and pre-filter maintenance. It is 12-18 months under typical conditions, but it can be as long as 3-5 years.

This product is for commercial use only and must be installed and maintained according to manufacturer's guidelines.

Do not use on water that is microbiologically unsafe or of unknown quality without adequate disinfection before or after the system.
